In relation to the devastating floods our Shire experienced last March I can draw no other conclusion than the Federal Government has ignored us and the State Government is toying with us.

I accept the number of submissions from the rural sector the first time around was not sufficient to declare a Cat C. Perhaps this was because so many farmers were too busy repairing the damage one of the worst floods in living memory had caused. The second application however is a different story, over 250 farmer submissions representing a total damage bill of over \$23M. This was given to the State Government on the 5<sup>th</sup> July. Seven weeks later we still wait for a determination, despite assurances made to me over three weeks ago that a decision would be made by now. Surely this is bureaucracy at its worst.

Our Local member, Adrian Piccoli must be too good a bloke because despite his strong representations on our behalf his Government has chosen to ignore him. You would think a Minister in the O'Farrell Government would be listened to, but apparently not.

We have written to the Attorney General, Nicola Roxon on two occasions. Once in June and the other more recently in July. On neither occasion has she bothered to respond to our pleas for assistance. The Attorney General hasn't acknowledged our letters in any way. This can only send a message to our community that we just don't come into their calculations. I think it is very disappointing.

The people of the Bland Shire devastated by these floods have every right to feel abandoned. Government at both Federal and State level have ignored their plight.

Up until now our community has been committed to completing the necessary Political and bureaucratic processes. It was difficult enough the first time to wait three months for the State Government to make a decision but in this instance, in regards to our second submission we feel we are being "strung-along. The bureaucrats have had our second application for seven weeks. There can be no possible justification for this. It just isn't good enough, we feel terribly let down. One of the worst floods in living memory can't get us across the line for a Cat C determination. What do we have to suffer to meet their requirements?

What really rubs salt into the wound is that thousands of Wagga residents were eligible for Government support within days of their flood event, even though not one drop of water entered their properties. Conversely the residential and business sector of Ungarie went under water and they can get nothing. Is it any wonder there is anger and frustration in the Ungarie community?

There are still people dislocated from their community in Ungarie. Six months after this flood people still can't return to their homes and business'. Some are forced to live in houses without floor coverings, walls and electricity. Some are living in the back yard in caravans. Some have had to temporarily leave town. I'd like to see some of our politicians live under these conditions. It might ground them a little.

The agricultural sector right across our Shire must be shaking their heads in disbelief. Thankfully Blaze Aid provided some support to some of the worst affected but with over \$23M damage there is still a significant negative ongoing legacy from this flood. It will have a long term impact on many of our farmers. People are in desperate need of State Government support. It is way past the time for the O'Farrell Government to step in. I am sure there are many people from our agricultural sector who expected a more understanding and supportive response from a Coalition Government. I am sure they feel let down badly.

The whole Cat C process is floored. It is broken. It doesn't work. It leaves those who need help the most left in a bureaucratic limbo. It needs to be fixed as a matter of urgency before we have another natural disaster and another community finds itself in the awful situation Bland Shire finds itself in.
